All participants must read this before registering

The race is organized by the "Float your Fanny Down the Ganny" committee. One copy of this form must be read and signed by each and every entrant and must be returned to the race organizers upon registration on Friday April 2, 2010 4-9pm or Saturday April 3, 2010 7-9am at the registration trailer on the riverbank at Cavan Street and Barret Street Bridge.

Rules to be followed

1. Life jackets must be worn by all participants
2. No alcohol or drugs are permitted before or during the event
3. Wet suits are highly recommended
4. No toxic drums or drums that once held pesticides solvents or oil products are to be used. All craft will be inspected before the race.
5. A rope is to be attached to the bow of the craft for safety
6. You must portage around the dam. (friends may assist you.)
7. **Everyone on the craft must be 13 years of age or older and if members are between the ages of 13 and 18 years, they must have a parental or legal guardian sign the consent on the waiver form.**
8. Participants are to exit the river just below the Barrett Street Bridge and the finish line will be the Barrett Street foot bridge.
9. Craft may be left in the municipal lot until 5pm. Please remove craft and any debris as soon after the race as possible.
10. Please remember that the spring spawning season is taking place so when entering the river, do so with care, stay in your craft and do not walk down the gravel beds as that is where the trout are spawning.

Individual Release and Waiver

1. **Danger!** I understand that in river racing there is a danger of serious injury and even death through hypothermia, drowning and other causes.
2. **Release.** I hereby remiss, release and forever discharge the organizers and sponsors of the "Float your Fanny Down the Ganny" River Race including but not limited to the directors and officers of the race committee and all the entrants and participants from any and all manner of action, causes of action, suits, claims, liabilities and demands whatsoever including but not limited to liability for negligence with respect to the "Float your Fanny Down the Ganny River Race.
3. **I understand** that I will not consume alcohol or narcotics prior to or during the race and if I appear to be impaired that the organizers will forbid the participation of me, my craft and my crew as the case maybe. The time of the craft will not be counted if any crew member was observed to be consuming alcohol or drugs.
4. **Cancellation:** I understand that the organizers may at any time cancel the race or discontinue the event at their discretion based on the condition of the river, the participants or other factors and that no part of the entry fee will be returned.
5. **Confirmation and acknowledgement:** by signing this release form I have read, understand, and accept the above listed rules and release conditions and have entered the race freely and voluntarily assuming any and all risk.
